Payment options: Personal Check, Cash or Credit Card. Wedding previews will be ready to view online 1 to 4 weeks from your wedding day. **The online gallery will be available for 90 days and the photos must be picked and/or purchased within that time or there is no guarantee that photos will be available.**

LIMIT OF LIABILITY: In the event of an emergency (natural, unnatural, medical, severe weather, etc.) beyond our control that prevents Charlie O's Photography from photographing your event every effort will be made to secure a quality replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to a refund of payments received and no refund will exceed the amount already paid. Charlie O's Photography takes the utmost care with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that the photographs have been lost, stolen, drive failure or destroyed for reasons within or beyond Charlie O's Photography control, Charlie O's Photography liability is limited to a refund of payments received and no refund will exceed the amount already paid. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. Charlie O's Photography recommends that CLIENT designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed. Charlie O's Photography will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for photographs. Charlie O's Photography is not responsible if key individuals fail to appear or cooperate during photography sessions or for missed images due to details not revealed to Charlie O's Photography.

Charlie O's Photography is the sole professional photographer allowed to photograph the event. Amateur photographers may take photos during the event if the do not interfere with the contracted photographer and only after the contracted photographer has finished taking the contracted photographs. If interference happens the contracted photographer will notify the designated "event guide" on site to handle the situation. Charlie O's Photography is limited by the guidelines of the ceremony official or reception site management. CLIENT agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is CLIENT's responsibility; Charlie O's Photography will offer technical recommendations only.

It is also understood that any and all images remain the property of Charlie O's Photography and they may be used for advertising, display or any purpose thought proper by Charlie O's Photography.
